

RESEARCHING A FORMER COMMISSION STAFF MEMBER - GUIDANCE SHEET



This bitesize guide is designed to help you research a former Commission staff member using the **CWGC Archive Catalogue**. Firstly, you will need to decide who you will research... this might be a relative, or you may have come across an individual like one of our Principal Architects whilst browsing the archive catalogue and wish to find out more information about them.

The first stage of your research starts with the CWGC Archive Catalogue. If the staff member was employed by the Commission between 1917 and 1969, there may be a staff card for the individual listed on the online archive catalogue. The staff card provides information such as their job title(s), their dates of employment, and the area(s) or region(s) they were employed. Some of the earlier staff cards even mention an individual's military service during the First World War, including their rank, regiment, and the number of years they were on active service.


STEP 1:

Staff cards use different combinations of full name, name and initial, and initials only. You may have to try several of these to find the individual you are looking for.


Individuals may only be referred to by their surname in some records listed in the catalogue, so it is advisable to use only the surname to start with.

For this guide, we will be looking for a former staff member named Stephen Grady. We will start by entering "grady" in the Quick Search box as seen in the image above.


After clicking the button labelled 'Search', you will then get a list of the results...

If you have not found who you are looking for, click Refine Search to carry out a more specific enquiry.

The search results display all of the records where the search term (in this example "grady") appears in the description of the record.




Scrolling further down the page we can see that Stephen Grady has a staff card available and as there is a thumbnail image visible, this means that his record has been digitised and is available to view on the online catalogue.



Once we have opened the catalogue entry for Stephen Grady's staff card, we can see there is lots of interesting information: it mentions when Stephen joined the Commission, that he died whilst in post in a motorcycle accident, and that his son (also called Stephen) was employed by the Commission


The **Date** field in the context of the staff cards refers to the individual's dates of employment (i.e. when they started and when they left the Commission)





If we scroll further down the page, we can see the staff card has been digitised and even includes a photograph of Stephen himself.

By looking at the staff card itself, we can find even more information about Stephen, such as where he was living in France at the time, his job before the First World War, and some information about his military service where it notes that he was a Gunner in the Royal Garrison Artillery:



Looking through the IWGC staff cards, you will notice several abbreviations that may be unfamiliar at first. Below are some common abbreviations which appear throughout the staff cards to help you:

A.R.I.B.A. – Associate of the Royal Institute of British Architects

A.T. - Agreement Terminated

C.A.O. – Chief Administrative Officer

C.B.E. - Commander of the Most Excellent Order of the British Empire

C.E.D. – Central European District

D.A.I.W. - Deputy Assistant Inspector of Works

D.W. – Director of Works

D.D.W. - Deputy Director of Works

E.D. - Eastern District

F.C. – Finance Committee

F.D. - French District

F.R.I.B.A. – Fellow of the Royal Institute of British Architects

G.& C. – Gardener (&) Caretaker

G.L. - Gardener Labourer

H.G. – Head Gardener

H.O. – Horticultural Officer (but is also used for Head Office)

I.W.G.C. - Imperial War Graves Commission

M.B.E. - Member of the Most Excellent Order of the British Empire

N.R. - Northern Region

N.W.E.D. – North West Europe District

O.B.E. - Officer of the Most Excellent Order of the British Empire

P.A. - Per Annum

P.M.S. – Permanent Maintenance Staff

If we return to the search results, we see that there may be several other records listed on the catalogue where Stephen Grady is mentioned.

Below is an overview of the other types of records you will expect to find on the catalogue and the type of information they are likely to hold on former Commission staff:

Personnel files

What are they?

Although many personnel files have since been destroyed, a few remain for some of the early Commission staff such as Sir Fabian Ware, or Principal Architects and even gardeners such as Robert Armstrong, who was murdered during the Second World War.

What can they tell us about Commission staff?

Most of the correspondence in these files concern the appointment and resignation of the staff member, but may also refer to their death and even include a photograph of the individual.

Are they available to access online?

None of the surviving personnel files have been as of yet digitised, but full catalogue descriptions exist for these files and they can be ordered for viewing in the Reading Room at the Commission's Head Office.

Staff Honours and Awards (CWGC/6/4/5/4)

What are they?

These files contain the staff recommendations for honours and awards as part of the New Years and Birthday Lists published annually in the Gazette.

What can they tell us about Commission staff?

Where a member of the Commission's staff has been recognised for their work and service and subsequently recommended for an honour or award, the Honours and Awards files will contain their recommendation which summarises their career with the Commission at that time and explains the reason why they were recommended for an honour or award.

Are they available to access online?

None of honours and awards files have been as of yet digitised, but catalogue descriptions list the staff members mentioned in these files. The files can be ordered for viewing in the Reading Room at the Commission's Head Office.

Annual Reports (CWGC/2/1)

What are they?

Annual reports of the Commission. Contents of each report generally include a list of the current Commissioners, a review of the work undertaken in the preceding year, an account of the finances of the Commission, and a statistical analysis of the number of cemeteries, memorials, graves, and commemorations maintained by the Commission. The reports may also contain information covering the final construction date of cemeteries and memorials and are often illustrated with images of sites.

What can they tell us about Commission staff?

Senior Commission staff members and Commissioners are often listed in the annual reports or if there was a significant event which involved a member of the Commission's staff, these are mentioned in the annual reports. Some later editions of the Commission's Annual Report list members of the Commission's staff who had retired or passed away in during the period covered in the report.

Are they available to access online?

All of the Commission's Annual Reports from 1919 to 2015 are available to access via the online catalogue in PDF format.

Commission meeting minutes (CWGC/2/2)

What are they?

Minutes of the Commonwealth War Graves Commission and predecessor/related organisations, including minutes of the Imperial War Graves Commission (1917-1960) and the Prince of Wales' National Committee for the Care of Soldiers Graves (1916-1917). The Commission Meeting Minutes record the discussions and decisions made by the appointed Commissioners regarding the policies and work of the Commission.

What can they tell us about Commission staff?

Only the earlier Commission meeting minutes in the 1920s will list the staff appointments at the time, but throughout the whole series, particular Commission staff members are mentioned who have been bestowed an honour or award, been present at an unveiling ceremony, or have toured a particular area or region.

Are they available to access online?

All the Commission's meeting minutes between 1916 and 2013 have been catalogued and digitised. The downloadable document is the final version of the Committee Meeting minutes. Additional information, including the verbatim minutes and subsidiary reports, may be available in the physical file.

Finance Committee meeting minutes (CWGC/4/2)

What are they?

The Finance Meeting Minutes record all financial aspects and costs incurred by the Commission during its work, including costs for cemetery and memorial construction, headstone production costs/contracts, and staff costs.

What can they tell us about Commission staff?

Mostly concerned with financial business, the minutes only mention aspects like employment, remuneration or staff expenses, however, there may be other details mentioned in connection with specific Commission staff.

Are they available to access online?

The Finance Committee meeting minutes have been catalogued, but they have not been digitised yet.

Photographic Collection (CWGC/9)

What is it?

Collection of photographic prints and negatives from the Commission's Photographic Library. Subject matter includes photographs of cemetery and memorial sites, Commission staff, and ceremonial events.

What can the photographic collection tell us about Commission staff?

Some photograph albums such as the Goodland collection depict the work and life of the early Commission staff and their families in France and Belgium, including the camps where they lived and worked or the social events they engaged in, including football, cricket and tennis tournaments.

Other images in the collection may show Commission gardeners or craftsmen at work or senior Commission staff whilst on tour.

Is it available to access online?

The black and white photographic negatives and some photograph albums (such as the Goodland collection) have been digitised and are available to access via the online catalogue, but there may be other images in the collection which can only be viewed on site in the Reading Room.
